Note: Make sure that you have the client software and installation guide for the media you are installing: VMS media, ULTRIX media, or diskettes.



VMS, ULTRIX, or OS/2 Server

You must install and configure the server software before installing the client software.

The server software and documentation is sold in a separate kit.

Consult the Server Installation Guide (available with the kit) for your particular server platform.

Microsoft LAN Manager User's Guide for MS-DOS

Explains how the Microsoft LAN Manager client works and how to use commands for the Enhanced and Basic versions.

DECnet Network Management Guide

Tells system administrators how to set up, tune, and maintain DECnet networks.

Describes all the basic client applications and user functions; includes a section on the basics of using PC DECwindows Motif and remote printers.

Explains how to configure PC DECwindows Motif and how to use the X server at your personal computer. For advanced users.



Mail User's Reference

Provides information on how to configure Mail; includes a complete reference for using all Mail options.



DECnet User's Guide

Provides information on using DECnet file transfer utilities between your personal computer and other computers on DECnet.



Microsoft Windows Support Guide

Explains how to configure Microsoft Windows to run on your personal computer; explains how to use the VT320 terminal emulator.
